**TERMS AND CONDITIONS

Participants agree to be bound by these terms and conditions (the **"Terms and Conditions"**). Any information or instructions published by the Promoter about the Promotion at <https://samsungoffers.claims/cashbackwithadifference> form part of the Terms and Conditions.

The Promoter

1. The Promoter is Samsung Electronics (UK) Limited, Samsung House, 2000 Hillwood Drive, Chertsey, Surrey, KT16 0RS (the **"Promoter"**).

Purchase Period

2. The Promotion will commence at 00:01 (GMT) on the 12th March 2025 and shall close at 23:59 (BST) on the 1st April 2025 (the **"Purchase Period"**).

Eligibility

3. To be eligible to participate in the Promotion you must be a UK (including Channel Islands or Isle of Man) resident aged 18+ (**"Individual Participant"**) or a company registered in one of the Territories (**"Company Participant"**) with a valid bank account in GBP. For the avoidance of doubt, within these Terms and Conditions the term 'Participant' shall be taken to refer to both Individual Participants and Company Participants (and the applicable plural) unless stated otherwise.
4. Rewards shall be paid by way of bank transfer and Participants must have a valid bank account in GBP in their name or the name of their business in order to receive the Reward.
5. Employees or agents of the Promoter that are involved in the operation of this Promotion or anyone professionally connected to this Promotion are not eligible to enter. Sales staff at the Participating Retailers are eligible to participate so long as they have not received a staff discount on the Promotion Product.

Offer

6. Participants who purchase a new (i.e. not second hand or refurbished) Samsung Television, projector or Sound Device listed in Table 1 (the **"Promotion Product"**) in-store or online listed **HERE** (the **"Participating Retailer"**) within the Purchase Period will be eligible to claim a cashback reward by redemption (the **"Reward"**). The relevant Reward value per Promotion Product shall be as set out in Table 1.
7. In addition, UK Participants who successfully submit a valid claim during the Claim Period (as set out below), will have the chance to enter in a 'Click to Reveal' chance-based mechanic (the **"Instant Win"**) to win one (1) additional Prize (**"Prize"**) from a selection set out in Table 2. In all cases, the Prize to be won is not dependent on the Promotion Product purchased. A weighted randomized process is used to pick all Prizes, which are allocated fairly and randomly by a computer algorithm. For the avoidance of doubt, only validated Claims will be eligible to claim a Prize.
8. Rewards shall be paid by bank transfer and Participants must have a valid bank account in GBP (for the UK, IOM or CI) in order to receive the Reward. For the avoidance of doubt Participants must have a valid bank account in their individual or company name and included on their Claim form to receive their Reward.

10. Purchases from auction websites (e.g. eBay) or from third party sellers on online retailers' websites (e.g. Amazon Marketplace) and non-Samsung approved resellers (non-direct accounts) are specifically excluded from this Promotion. Purchases from Amazon.co.uk must be sold and dispatched by Amazon UK directly, not Amazon EU or other non-UK branches.

Claims

11. After purchasing a Promotion Product from a Participating Retailer during the Promotion Period, Participants must visit <https://samsungoffers.claims/cashbackwithadifference> complete the claim form with their name, contact information, bank account details and any other requested information, and submit it together with a scanned copy of their proof of purchase (a "**Claim**"). Participants will be required to upload an image of the serial number from the settings screen, or the back of the TV, of the Promotion Product (rather than the packaging). For the avoidance of doubt the Promotion Product(s) must be purchased in order to be eligible for Rewards in this Promotion; Promotion Product(s) received for free or as part of a giveaway do not qualify.
12. Claims may only be submitted between thirty (30) and sixty (60) days after the date of purchase ("**Claim Period**"), meaning the final claim date for purchases made on 1st April 2025 is no later than 23:59 (BST) on 30th May 2025. Claims received outside the Claim Period will not be eligible. For the avoidance of doubt, the date of purchase counts as day one (1).
13. In the event of late delivery of the Participant's Promotion Product(s), Participants will be able to indicate on the Claim form that they have not received their Promotion Product, register and save their information in the Claim form during the Claim Period and return to complete and submit their Claim within one (1) to sixty (60) days of commencing their Claim. The claim will automatically expire after sixty (60) days if the missing information has not been submitted by this time and will no longer be eligible to claim.
14. Participants will be sent an email and SMS within five (5) days of submitting their Claim to confirm that their Claim has been received by the Promoter and that it has been successful and approved ("**Claim Approval**").
15. Participants will be notified instantly after clicking the mechanism to confirm their provisional Prize, subject to Claim Approval. Participants will then receive a Claim Approval email within five (5) business days containing instructions on how to accept or reject the Prize (which they have fourteen (14) days in which to do). Once the instructions have been satisfied or after fourteen (14) days have lapsed, Participants will be sent confirmation via

If no response is received, then the Claim shall be marked as invalid, and the Participant will no longer be eligible to receive the Reward.
18. Claims that are incomplete or damaged will be deemed invalid. No responsibility is accepted by the Promoter for lost, delayed or damaged data which occurs during any communication or transmission of Claims.
19. The Reward will be paid via bank transfer within forty-five (45) days of Claim Approval to the bank account provided by the Participant during the Claim process, which must match exactly with their name on the Claim form. Digital Prizes will be sent via email within forty-five (45) days of Claim Validation to the email address provided by the Participant, and physical Prizes will be dispatched to the address provided within forty-five (45) days. Disputes regarding a Prize delivery must be made no later than 30 days from the date the despatch notification email has been sent to you.
20. Participants are solely responsible for ensuring the accuracy of the bank account details they provide during the Claim Process. In the event that incorrect bank details are submitted, and payment is successfully made to the provided account, the Promoter will not be liable for any resulting issues or customer escalations. Additionally, no additional payment will be made to the correct account.
21. The Promoter shall have the right, where necessary, to undertake all such action as is reasonable to protect itself against fraudulent or invalid Claims including, without limitation, to require further verification as to proof of purchase, as well as the identity, age and other relevant details of a Participant. In the event your information is linked to fraudulent claims or abuse of terms and conditions on previous promotions you will be unable to participate in this Promotion and your Claim will be rejected.

23. A Claim must be made by the Participant, and must not be made through agents, third parties or in bulk.

Privacy and Data Protection

The Participant may withdraw consent to such use of personal information by writing to the Promoter or by using the opt-out process outlined in the Promoter’s privacy policy.

25. Other than as set out in these Terms and Conditions, the details and information provided by the Participant when entering the Promotion or claiming the Reward will not be used for any other purpose, nor shall they be passed to any third party.

General

26. The Promoter shall not be liable for any interruption to the Promotion whether due to force majeure or other factors beyond the Promoter's control.
27. The Promoter reserves the right, acting reasonably and in accordance with all relevant legislation and codes of practice, to vary the Terms and Conditions of the Promotion.
28. The Promoter will not be responsible or liable for: (a) any failure to receive submissions due to transmission failures and other conditions beyond its reasonable control; (b) any late, lost, misrouted, or damaged transmissions or claims; (c) any computer or communications related malfunctions or failures; (d) any disruptions, losses or damages caused by events beyond the control of the Promoter; or (e) any printing or typographical errors in any materials associated with the Promotion.
29. Participants will be solely responsible for any and all applicable taxes and any other relevant costs or expenses which are not stated in the Terms and Conditions as included in the Reward.
30. By participating in this Promotion, you agree, to the maximum extent permitted by applicable laws, to release and hold the Promoter harmless from any and all liability whatsoever for any injuries, losses or damages of any kind arising from participation in or in connection with the Promotion, including without limitation, awarding, acceptance or receipt of the Reward. The above limitation of liability shall not apply to death or personal injury caused as a result of Promoter's negligence.
